From the President...



No, you haven't missed anything. We have not yet mailed an announcement for the NESPS meeting this fall. As you recall, the 2004 meeting will be held in **January 19-23, 2005 in Naples Florida**, outside our usual time slot and outside our usual region. How is that for thinking outside the box?

The Naples meeting is shaping up to be an exciting event, both scientifically and socially. Here are some of the highlights:

Golf Tournament — On Thursday, the opening day of the meeting, there will be a golf tournament at Naples Grande golf course, rated one of the top 100 courses in the US. **Steve Colen** is arranging the festivities. Thanks to our sponsors **Mentor, LifeCell and Inamed**. We will be able to offer this wonderful golfing experience for \$50 per person rather than the usual greens fees of \$150. Three cheers for **Steve, Joe Disa** and **Lou Bucky** who have helped solicit support from our sponsors.

Scientific Session — The program chairman for the meeting is **Geoff Gurtner** who is Chief of Microsurgery and Research and the program director at NYU. In addition to free papers, there will be panels on *Lower Eyelid Blepharoplasty* moderated by **Jim May**, *Breast Reconstruction* moderated by **Mark Sultan**, *Orbital Fractures* moderated by **Paul Manson**, *Digital Imaging* (see below) moderated by **Dick Dabb** and *Forehead/Browlifting* (moderator yet to be drafted).

Digital Photography Seminar — In addition to the panel on Digital Imaging during the scientific session, **Dick Dabb** has organized optional seminars to be held on Thursday (during the golf tournament for the non-golfers) and on Saturday afternoon, to instruct registrants and any spouses, family or guests, in the basics and nuances of digital imaging. **Dick** has enlisted support from Canfield company and Apple Computer to provide this exciting seminar which will address questions from "What kind of digital camera should I buy?" to "How can I take advantage of the latest imaging technology in my practice?"

Special Lectures — The **Gene Courtiss** Memorial Lecture on cosmetic surgery will be delivered by **Tom Baker**, a good friend of Gene's. Our own NESPS past president **Scott Spear**,

president of ASPS at the time of our meeting, will give the Keynote address. **Scott** is uniquely positioned to provide insight into the current issues in Plastic Surgery.

Awards — In addition to the traditional awards for the best clinical and research papers presented by a resident, a **new award** has been added this year. **The Presidents' Award** will honor the best paper presented by a non-resident or member of the NESPS. Only former presidents of the NESPS in attendance at the meeting will be entitled to vote for this prestigious new award. The winner will receive a plaque and free registration for the November 2005 meeting at the new Ritz-Carlton Hotel in Washington, DC. All awards will be presented at the dinner on Saturday night and will hopefully become a tradition of the society.

New Ideas — The Board is recommending a new special lecture be added to the annual meeting to complement the existing Courtiss lecture. Since the latter is devoted to cosmetic surgery, we hope the membership will authorize the establishment of an invited lecture devoted to a reconstructive topic. The name of this new annual lectureship is open for debate but the principle, we think, is of obvious merit.

Hotel — The meeting will be held at the Naples Beach Hotel and Golf Club, an informal, family owned hotel, directly on the beach and the hotel's own 18 hole golf course, and very near the upscale downtown area of Old Naples. Restaurants and great shopping abound in town, and there is an abundance of family activities in the area. The hotel is charming and the location is out-of-this-world. The beachside bar has been consistently voted "the best bar in Naples" by the locals for its perfect view of sunsets and great Margaritas.

Resident's Corner

We have interviewed for the Integrated Model resident already and will interview for the Independent Model resident in March.

Furthermore, participants in TOPS can earn up to 30 Category 1 CME hours without leaving the office.
