Dear Colleagues:

Call to Order and Welcome

President Joseph Disa, MD welcomed everyone to Amelia Island and called the 28th Annual Meeting of the Northeastern Society of Plastic Surgeons to order at 12:10 pm on Saturday, October 22, 2011.

Dr. Disa appointed Drs. Brian Glatt and Peter Taub as Tellers to collect and compile the membership ballots. The Parliamentarian, Dr. Brian Glatt, declared a quorum present.

Approval of the Minutes of the October 30, 2010

Annual Business Meeting

Dr. Disa indicated that the minutes of the October 30, 2010 Annual Business meeting had been distributed and asked for a motion to approve the minutes.

It was VOTED to approve the minutes of the October 30, 2010 Annual Business meeting as distributed.

Secretary's Report

Dr. Joseph Serletti, Secretary, reported that the membership continued to grow. The current membership totaled 578 comprised of 379 Active, 103 Life, 28 Candidate, 6 Associate, 5 Honorary and 57 Resident members.

Dr. Serletti reported that the NESPS had received applications for membership from 26 applicants including 17 for Active membership and 9 for Candidate membership. Each of these prospective members has met all of the NESPS qualifications and requirements for membership. In accordance with our By-Laws, all prospective members were presented to the Board. Based on Board recommendation, they are included on the membership ballot. He thanked Membership Chair, Jeffrey Ascherman, for his excellent work as well as the members for their vigorous efforts to continue to seek out the highest and best-qualified candidates for NESPS membership.

Report of the President

Dr. Disa reported that NESPS continued to raise funds for the Second Decade Fund. The NESPS Second Decade Fund was inaugurated 16 years ago by Dr. Bill Little to support the educational efforts of the NESPS. In the past the fund has allowed us to support the annual Eugene Courtiss Memorial Lecturers and fund the President's Awards at our Annual Meetings. This fund has also helped the NESPS weather the current economic recession. Dr. Disa acknowledged the contributors to the fund and thanked them for support and urged others to pledge their support of the fund.

Treasurer's Report

Dr. John Giroto presented the Society's financial status noting Assets of \$245,261 with \$115,013 in the Operating Ac-

count and \$130,248 in investments at UBS. With total revenue through September 30, 2010 equaling \$175,050 and expenses totaling \$97,129 with the addition of \$8,079, the financials reports recognized a surplus of \$86,001.

It was VOTED to approve the report of the Treasurer.

Report of the Program Committee

Georgetown University Hospital Department of Plastic Surgery
